The initiative aims at the preservation, learning and protection of heritage/languishing crafts.

Whereas Maharaja Bijli Pasi Government. P.G. College, Ashiana, Lucknow is a leading institution in imparting higher education to the students of Lucknow and around in the field of Commerce, Arts and Science.

Whereas Disha Pragati Foundation, "Ek Disha Pragati ki Orr" Lucknow, Uttar Pradesh situated at Jankipuram, Lucknow is a Non-Government Organization that promotes heritage crafts with special focus on skill development.

Role of First Party:

- Organising workshops for the students to promote Art and Craft through creative methods.
- Aim to create awareness about Indian contemporary and heritage art, increase prospects
 for artists, and develop an ongoing dialogue between arts, artists and the people through
 various events, education and public art projects.

Role of Second Party:

- Making availability of students of college for workshops and training in compliance of GOI mission of Skill Development
- Organising schedule and making availability of students to enhance their skills through Workshops/vocational training

Validity of MOU

The MOU shall become effective from the date of signing by both the parties and shall be valid for a period of O1(one) year from the date of signing by both the parties. The MOU can be extended for a further period of 01 year with mutual consent and agreement.

The MOU can be terminated by either of the parties by giving 01(one) month notice in writing but without any binding/cost to any of the party.

Compliance of Law

Both the parties shall perform their role in strict compliance with the prevailing and applicable laws of India along with rules and regulations of the Government as applicable.

Confidentiality

Both the parties agree to keep the terms of MOU in strict confidence and not to disclose to any third party or use for any purpose (other than in connection with this MOU) any information related to the others which is marked "Confidential".

Both the institutes agree to the above in principle, subject to the completion of such other

formalities required by them.
