ANALYSIS OF ALUMNI FEEDBACK








The curriculum meets the prerequisite and basic knowledge required for the career.



ANALYSIS OF STUDENT FEEDBACK






Rate the curriculum and syllabi of the course 797 responses




Rate the size of the syllabus in terms of the load on the student. 797 responses




Rate the extent of the coverage of syllabi in the class




Rate the usage of teaching aid and ICT in the class by the faculty 797 responses




Rate the course content in encouraging extra learning or self-learning 797 responses




Rate the effectiveness and relevance of the electives/value-added courses offered in the syllabi 797 responses




Rate the opportunity for students to participate in internships, field visits and academics 797 responses




Rate the frequency of guest lectures/seminars/workshops/competitions organized by the faculty 797 responses

ANALYSIS OF TEACHER FEEDBACK

The feedback received from our teaching faculty, meticulously recorded on a five-point scale spanning from "Strongly Agree" to "Strongly Disagree," offers a profound insight into various dimensions of the college's academic infrastructure and support mechanisms. A meticulous analysis of this feedback provides a nuanced understanding of the perceptions and experiences of our educators:

- 1. Clear Learning Objectives: 89.5% of faculty members concur that the learning objectives are lucid and aptly tailored to the respective academic programs. This resounding consensus underscores the college's success in formulating and aligning educational objectives with program requisites.
- 2. Well-Organized Curriculum: A substantial 81.6% of educators find the curriculum and syllabus to be meticulously organized and pertinent to the academic programs they oversee. This signifies adept institutional structuring of academic content.
- 3. Appropriate Textbooks/Reference Books: An overwhelming 87.7% of teaching faculty concur that the prescribed textbooks and reference materials are well-suited to the courses they deliver. This reinforces the quality of educational resources available.

- 5. **Provision for Curriculum Updates:** Approximately 70.2% of faculty members acknowledge the provision for curriculum updates, denoting the college's commitment to updating itself with evolving knowledge paradigms and industry trends.
- 6. Balanced Theory and Practice: A substantial 71.9% of teaching faculty perceive the curriculum as striking a harmonious equilibrium between theoretical and practical components. This underscores the institution's commitment to holistic learning experiences.
- 7. Clear Course and Program Outcomes: The majority, a comprehensive 82.5%, commend the clarity and precision of course and program outcomes, laying a robust foundation for teaching and assessment.
- 8. Academic Flexibility: A resounding 80.7% of faculty members appreciate the academic flexibility embedded in the syllabus, facilitating diverse pedagogical approaches.
- 9. Availability of Prescribed Books: While 12.3% strongly agree, a total of 59.7% agree that an adequate number of prescribed books are accessible in the library. This underscores the importance of enhancing library resources.






The learning objectives are clear and appropriate to the program. 57 responses




The curriculum and syllabus are well-organized and suitable for the program 57 responses




The textbooks/reference books are well-suited to the course 57 responses




How do you rate the distribution of contact hours among the course components? 57 responses



The course outcomes and program outcomes are well-defined and clear 57 responses




The syllabus has good academic flexibility 57 responses




The system followed by the university for the design and development of the curriculum is effective.




There is a provision to update curriculum from time to time.



The curriculum has a good balance between theory and practice.




A sufficient number of prescribed books are available in the Library.




The University provides adequate funding and support to faculty members to upgrade their skills and qualifications.
